### The Law Centre specialises in these areas of law:

- **HOUSING** for tenants, licensees and homeless people, possession proceedings and warrants for eviction, service charges, disrepair, succession, homelessness and suitability.

The Law Centre is not able to advise landlords.

- **ASYLUM SUPPORT**, community care, NASS and welfare benefit issues for asylum-seekers/refugees.
- **IMMIGRATION and ASYLUM** problems, asylum claims and appeals, family reunion, entry clearance and appeals, problems with naturalisation and registration, residence for EEA nationals and their families.

- **EMPLOYMENT** rights for employees and workers including unfair dismissals, discrimination in the workplace, maternity/paternity rights, protection of wages.

The Law Centre is not able to advise employers.

- **COMMUNITY CARE** assessments, problems over charging and provision of services.
