

SUMMARY OF FEES - LICENSING ACT 2003

Premises

Premises and club application and annual fees – each premises that is licensable will be allocated to a fee band according to rateable value

NB: RATEABLE VALUE IS DIFFERENT FROM THE VALUE OF THE PROPERTY, SO PLEASE CHECK THAT YOU HAVE THE CORRECT RATEABLE VALUE FOR YOUR PROPERTY.

| Main Application Fee | 100 | 190 | 315 | 450 | 635 |
| Main Annual Charge | 70 | 180 | 295 | 320 | 350 |

Premises under construction without a specified rateable value will be in Band C.

Educational premises/church hall/village hall/parish hall/community hall or similar buildings are exempt from paying a fee if alcohol is not supplied or sold.

Rateable Values

Additional Premises fees

A multiplier is applied to premises in bands **D and E** where they are exclusively or primarily in the business of selling alcohol.

Fee for variations of Premises Licences

Premises also **applying to vary conditions** in relation to the sale of alcohol during transition will be charged an additional fee, according to their fee band
