

## **Regulation of Commodities**

1. All types of commodities, which are not prohibited by the London Local Authorities Act 1990, Food Safety Act 1990, Consumer Protection Act 1987, or the Trade Descriptions Act 1968, are eligible to be licensed in Hammersmith and Fulham Street Trading and Market sites.
2. Licences are divided into categories. A trader is licensed to sell up to three compatible or complimentary commodities within a category on their street trading licence. The licensed commodities must be specified, both on the Trader's Licence and on the Pitch ID Card, which must be displayed on the stall at all times.

### **Categories and Banding**

Licence holders may trade up to three commodities from one category.

1. 2. 4. Food
- a) Pre-packed groceries (including ethnic specific)

  - e) Dried fruit & pulses (peas, beans, seeds, nuts, raisins, dates etc.)
  - f) Pre-packed confectionary
  - g) Pre-packed cheese & dairy products & eggs

5. Flowers
- a) Cut flowers and plants

  - c) Artificial flowers
  - d) Plant pots/bulbs/seeds/food
  - e) Christmas trees/holly/mistletoe (Seasonal)
  - f) Other (must be specified)
6. Household Goods
- a) Cleaning products (kitchen/bathroom/multi surface, bleach, disinfectant, air-freshener, washing-up liquid, dishwasher tablets, polishes etc.)
  - b) Laundry products (washing powder/liquids/tablets, fabric softener, dryer sheets etc.)
  - c) Cleaning utensils (brooms, dustpan, mops, buckets, scrubbing brushes, chamois, sponges, cloths, tea-towels, etc.)
  - d) Storage & access (crates, boxes, chests, steps, etc.)
  - e) Light bulbs, plugs, multi-sockets, fuses
  - f) Ornaments, vases, pictures, clocks, etc.
  - g) Toiletries (toothpaste, soap, deodorant, hair remover, body-lotion, shower gels, bath oils, etc.)
  - h) Hair care (shampoo, conditioner, hair-dye, hair spray, perm/straightening products, hair mousse/grease/lotion/oil etc)
  - i) Other (must be specified)
7. Soft Furnishings
- a) Bedding (sheets, duvets-covers, pillow cases, throws, mattress/pillow protectors, etc.)
  - b) Towels, bath mats & shower curtains
  - c) Curtains and net curtains
  - d) Blinds
  - e) Duvets, pillows, cushions & cushion covers
  - f) Carpets, mats and rugs
  - g) Tablecloths, furniture protectors, chair covers, etc.
  - h) Other (must be specified)

8. Kitchen/Dining
- a) Tableware (crockery, oven-to-table ware, cutlery, table-mats, coasters, etc.)
  - b) Glassware (glasses, decanters, ashtrays, fruit bowls, etc.)
  - c) Kitchenware (roasting dishes, pots, pans, casserole dishes, scales, etc.)
  - d) Other (must be specified & not electrical)
9. Toiletries and Cosmetics
- a) Skin Care (make-up remover, facial wash, toner, moisturiser, shaving cream, etc.)
  - b) Hair care (shampoo, conditioner, hair-dye, hair spray, perm/straightening products, hair mousse/grease/lotion/oil etc.), wigs, hair pieces etc.
  - c) Make-up (including nail polish & remover)
  - d) Perfume/cologne/aftershave/eau de toilette

10. Electrical
- a) Audio equipment and accessories (eg. radios, stereo equipment, iPods/MP3 etc. including associated aerials, batteries, adapters etc.)
