The application will be refused if in the period of five years ending with the date of the application:
(a) an operating licence held by the society has been revoked under section 119(1) of the Gambling Act 2005, or
(b) an application for an operating licence made by the society has been refused.
The application may be refused if the local authority think that:
(a) the society is not a non-commercial society,
(b) a person who will or may be connected with the promotion of the lottery has been convicted of a relevant offence, or
(c) information provided in or with the application is false or misleading.



GAMBLING ACT 2005 SOCIETY LOTTERY—ELM FORM

It is common practice in the lottery sector for organisers of lotteries to employ third parties to provide materials and services to assist in the promotion of lotteries.

Those third parties are generally commercial companies and include ticket printers, advertising agencies, response handling, telemarketing and direct mail companies etc. In many cases those third parties will simply be acting as 'service providers' rather than being involved in the promotion or facilitation of the lottery and they will not require a licence or any other specific permission under the Gambling Act 2005 (the Act).

What is an External Lottery Manager (ELM)?

1 Society Details

Under the Act a third party will require an operating licence from the Commission if the services the third party provides amounts to the promotion or facilitation of a lottery under section 252 or 259. Under the Act a society or local authority lottery may employ a third party (an ELM) to promote all or part of its lottery. Section 257 of the Act defines an ELM as a person or body that makes arrangements for a lottery on behalf of a society or authority of which they are not a member, officer or employee.
