WHEREAS the Council of the London Borough of Hammersmith and Fulham (hereinafter referred to as "the Council") is the appropriate local planning authority for the purposes of Part of III of the Town and Country Planning Act 1971 and the Town and Country Planning General Development Orders 1977 to 1983 (hereinafter referred to as "the 1971 Act" and "the Development Orders" respectively) in respect of the area which includes the properties described in Schedule 1 hereto (hereinafter referred to as "the Properties")
- The Properties are situate within the Mall Conservation Area (hereinafter referred to as "the Conservation Area") designated by the Council pursuant to the provisions of the 1971 Act.
- 3. AND WHEREAS in the opinion of the Council any development of the Properties in the manner described in Schedule 2 hereto would be prejudicial to the proper planning of the Conservation Area and would constitute a threat to the amenities of the Conservation Area AND FURTHER the Council consider that such development should therefore be subject to control by the Council.
- 4. NOW THEREFORE TAKE NOTICE that the Properties shall be subject to control by virtue of this Direction made under Article 4(1) of the Development Order. The effect of Part 1 of this Direction is that

notwithstanding the provisions of Article 3 of the Development Orders the development of the Properties in the manner described in Schedule 2 hereto shall not be carried out unless planning permission has been granted either by the Council or the Secretary of State for the Environment.

You may recall that I sent you a letter dated 3 September 1982, requesting your comments regarding proposals for an Article 4 Direction. I am now writing to inform you that the Department of the Environment has confirmed the Direction, which becomes effective from today.

In the case of your property, the Direction means that you will no longer be able to carry out the repainting of the stucco on external walls in any colour other than that existing today, without first obtaining planning permission.

The Direction is identical to one existing on stucco fronted Listed Buildings in the Conservation Area. The Council in both instances advocates the use of White British Standard OOEE55.
