

# Deprivation in Hammersmith and Fulham

## The Indices of Deprivation 2019

Deprivation indices are a measure of the level of deprivation in an area and are grouped into seven domains:

**Income, Employment, Education, Health, Crime, Barriers to Housing and Living Environment.**

These domains combine to create the **Index of Multiple Deprivation (IMD)**.

The IMD is the official measure of relative deprivation for small areas (or LSOAs) in England.

### HEADLINE FIGURES

Hammersmith and Fulham is ranked **112** out of 317 English Local Authority Districts (where **1** is the **most deprived**).

In 2015 H&F was ranked 91.

**112** ↑

Hammersmith and Fulham is ranked **16** out of 33 London Boroughs.

In 2015 H&F was also ranked 16.

Of the 113 LSOAs in Hammersmith and Fulham **1** (0.9%) is in the most deprived 10% nationally (Clem Attlee estate).

This is down from 8 (7.1%) in 2015.

### BEST AND WORST RANKINGS (1 MOST DEPRIVED – 317 LEAST DEPRIVED)

Hammersmith and Fulham's ranking in the **Education Deprivation** domain is **300**.

In 2015 H&F's ranking was 306.

Hammersmith and Fulham's ranking in the **Health Deprivation** domain is **141**.

In 2015 H&F's ranking was 99.

**141** ↑

Hammersmith and Fulham's ranking in the **Employment Deprivation** domain is **133**.

In 2015 H&F's ranking was 146.

Hammersmith and Fulham's ranking in the **Income Deprivation Affecting Children Index sub-domain** is **91**.

In 2015 H&F's ranking was 37.

**88** ↑

Hammersmith and Fulham's ranking in the **Income Deprivation** domain is **88**.

In 2015 H&F's ranking was 75.

**63** ↑

Hammersmith and Fulham's ranking in the **Crime Deprivation** domain is **63**.

In 2015 H&F's ranking was 39.

Hammersmith and Fulham's ranking in the **Barriers to Housing and Services Deprivation** domain is **34**.

In 2015 H&F's ranking was 79.

**25** ↑

Hammersmith and Fulham's ranking in the **Living Environment Deprivation** domain is **25**.

In 2015 H&F's ranking was 7.

Hammersmith and Fulham's ranking in the **Income Deprivation Affecting Older People Index sub-domain** is **17**.

In 2015 H&F's ranking was 17.

### Number of LSOAs in Hammersmith and Fulham that fall within the 10% most deprived areas nationally by type of deprivation



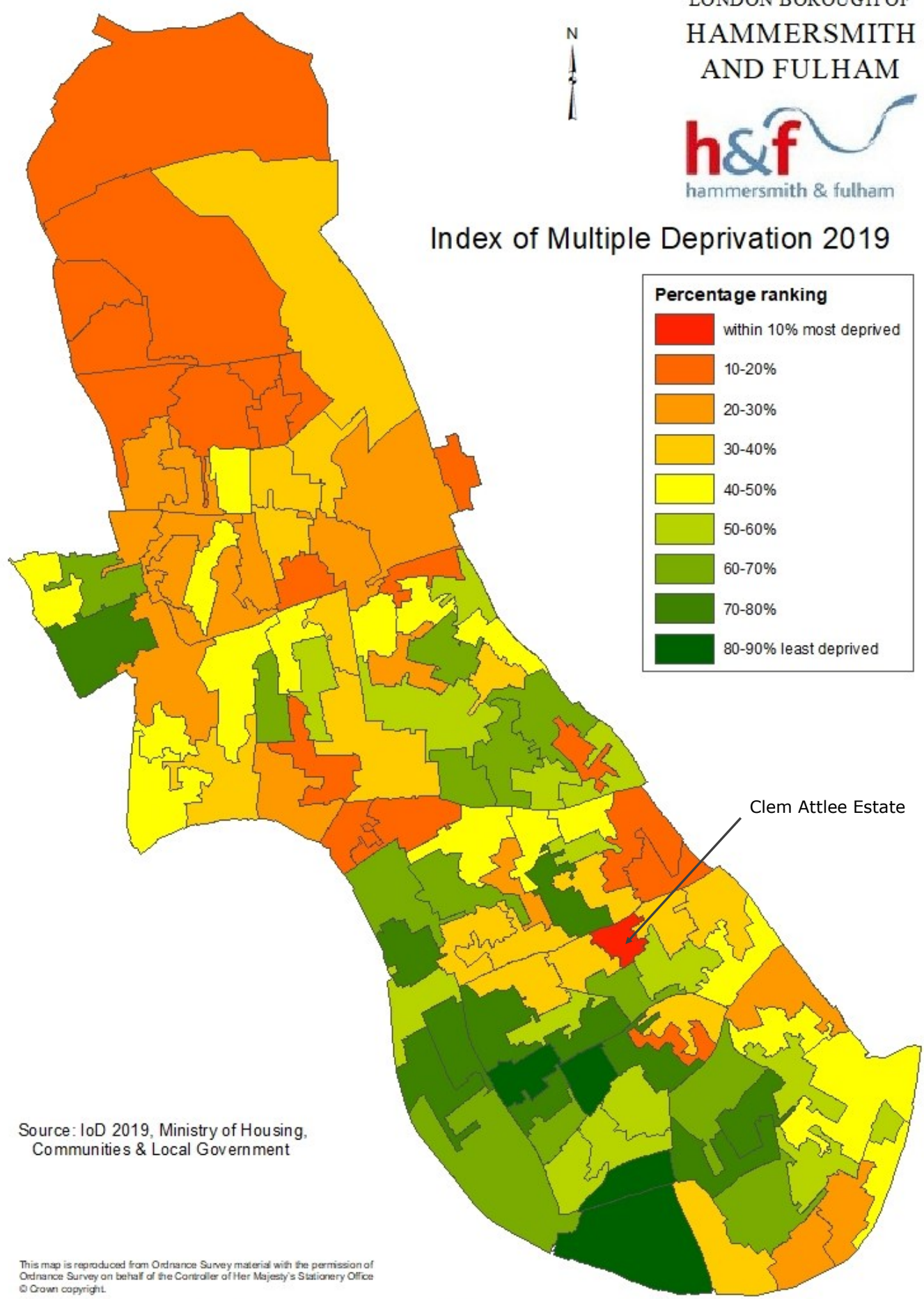
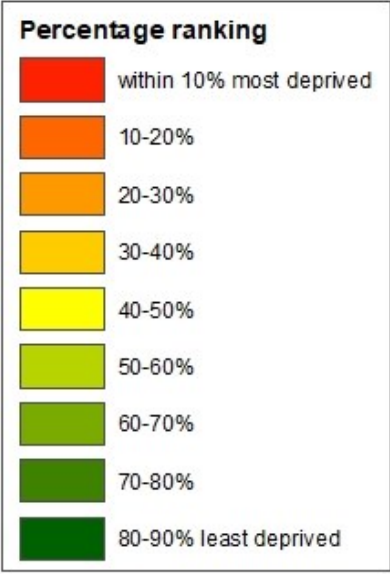
Two supplementary indices: Income Deprivation Affecting Children (IDACI) and Income Deprivation Affecting Older People (IDAOPI). These two indices are sub-models of the income domain, and as such do not feed into the overall IMD.
