

ADOPTION STATEMENT – LOCAL PLAN 2018

In accordance with Regulation 26 and 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012 notice is hereby given that the London Borough of Hammersmith and Fulham adopted the Hammersmith and Fulham Local Plan on 28th February 2018.

A number of modifications were made to Local Plan pursuant to section 23 of the Planning and Compulsory Purchase Act 2004. The main modifications were confirmed by the Inspector appointed by the Secretary of State and are set out in the published Inspector's Report. A number of minor modifications have also been included as necessary technical changes resulting from representations received during the public consultations and at the hearings sessions held in June 2017. The main and minor modifications may be viewed at the Council's website (www.lbhf.gov.uk/localplan). The recommended main and minor modifications have been included in the adopted Local Plan which now carries full weight in the consideration of planning applications and replaces the Core Strategy (2011) and Development Management Local Plan (2013) policy documents.

Any person aggrieved by the Local Plan may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the grounds that:

- (i) the Hammersmith and Fulham Local Plan is not within the powers conferred by Part 2 of the Planning and Compulsory Purchase Act 2004;
- (ii) a procedural requirement of the Act or its associated Regulations has not been complied with.

Any such application must be made promptly and in any event not later than the end of the period of six weeks starting with the date on which the Local Plan was adopted.
