### **Employment concentration in LBHF compared to other Boroughs, London, England and the UK**

#### **Notes on data**

- **LQ** refers to Location Quotient and reflects the relative density of a sector within a geography. An LQ of 1.00 indicates that the local density is the same as that of the reference, eg Great Britain. An LQ greater than 1.00 indicates a local concentration whereas an LQ of less than 1.00 reflects a relative scarcity. An LQ of 1.25 or greater is usually seen as an indicator of colocation.
- **SIC** refers to Standard Industrial Classification of Economic Activities (SIC). The United Kingdom Standard Industrial Classification of Economic Activities (SIC) is used to classify business establishments and other standard units by the type of economic activity in which they are engaged.
- **Location quotients were calculated using:**
  - BRES data
  - all employment
  - 3-digit SICs in Local Authorities
- **LQs have been calculated for**
  - Hammersmith and Fulham
  - Brent
  - Ealing and Kensington and Chelsea.
