Traffic Management Order

The Hammersmith and Fulham (University Boat Race) (Temporary Restriction of Traffic) Order 2018

The Council of the London Borough of Hammersmith and Fulham, being the highway authority for roads in the said borough, is satisfied that to facilitate the safe movement of traffic and pedestrians during the 2018 Universities Boat Race on the River Thames, it made an Order the effect of which imposes temporary restrictions on vehicular traffic in the roads shown in Article 2 of this notice.

The Council, in exercise of their powers conferred by section 14 (1) of the Road Traffic Regulation Act 1984 (a) as substituted by the Road Traffic (Temporary Restrictions) Act 1991 (b) and the Road Traffic (Temporary Restriction) Act 1991 (c) and of all other enabling powers, hereby make the following Order:-

1. This Order shall come into operation on the 21st March 2018 and may be cited as The Hammersmith and Fulham (University Boat Race) (Temporary Restriction of Traffic) Order 2018.
2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Hammersmith and Fulham (University Boat Race) (Temporary Restriction of Traffic) Order 2018, shall have effect as follows:-
 - (i) On the day of the 2018 Boat Race, when instructed by the Council or Police, and whilst the authorised traffic signs are in place, no person shall cause any vehicle to proceed across, stop, wait, load or unload on **Hammersmith Bridge**.
 - (ii) For the duration of this order and whilst the authorised traffic signs are in place, no person shall cause any vehicle to stop, wait, load or unload between 8am and midnight, on the day the 2018 University Boat Race on the River Thames takes place and four days before that day, in the roads specified in this schedule:
 - (a) **BRIDGE VIEW.**
 - (b) **HAMMERSMITH BRIDGE ROAD**, between Rutland Grove and Lower Mall.
 - (c) **MALL ROAD.**
 - (d) **OIL MILL LANE.**

- (e) **QUEEN CAROLINE STREET**, the north-east to south-west arm, the north-west side, from a point 12.00 metres north-east of its south-westernmost extremity to a point 62.00 metres north-east of that extremity.
- (f) **RIVERCOURT ROAD**, between Great West Road and Upper Mall.
- (g) **RUTLAND GROVE.**
- (h) **SOUTH BLACK LION LANE.**
- (i) **STEVENAGE ROAD**, the south-west side, from a point 3.75 metres north-west of the common boundary of Nos. 14 and 16 Stevenage Road, to a point 15.00 metres south-east of that point.
- (j) **WELTJE ROAD**, between Great West Road and Upper Mall.

(iii) On the day of the 2018 Boat Race, when instructed by the Council or Police, and whilst the authorised traffic signs are in place, no person shall cause any vehicle to proceed across, stop, wait, load or unload in **Rutland Grove**.

3. The temporary restrictions of this order do not apply in respect of:

- (i) a vehicle being used for fire brigade, ambulance or police purposes,
- (ii) anything done with the permission of a police constable in uniform or a Council employed parking attendant,
- (iii) a vehicle or trailer authorised by an officer from the Council to be used in connection with the said Boat Races.

4. This order will come into effect on Wednesday, 21st March 2018 and will cease to be in effect at midnight on those Boat Race days.


5. This Order will be valid for a maximum period of 18 months.
