## Introductions and news



Tara told the group that she is still looking for 2 new people to join the DPC:

- A deaf person
- A young disabled person (speaking to Safety Net Youth about this)

Tara was very happy to tell the group that Kevin Caulfield has been given the job of policy and research support.
Kevin will start next week and will work for 18 hours each week.

Discussion: How will we know if the DPC has been successful?


Victoria suggested doing a survey of disabled people now and then again in 2 years.
This would help the DPC see if they had made a change in people's lives.


Tara and others in the group thought this was a good idea. The group agreed that the survey should be short and that Kevin and Tara would come up with some questions.


It was suggested that a couple of events would help get people involved, too.


Councillor Lukey thought that a survey for councillors and senior managers at the council could also be a good idea.

This survey would also be to see how the DPC has changed things - but this survey would look at the way it has changed things for staff and professionals.

Tara explained that she thinks the DPC group is very diverse and involves lots of different people.
But, Tara wants to make sure the DPC still talks to lots of different disabled people in H\&F.

The group talked about whether the survey should ask about carers or even involve carers.

It was agreed that this was not the reason for starting the DPC.

Dave did say that we need to think about how we ask the questions.

A lot of people worry about being polite or causing a stir this means they will not always answer questions fully.

Tara explained that she would like the commission to come up with a 'checklist' or 'toolkit' for co-production.

People thought this was a good way of making sure the DPC's work has an impact and lasts into the future.

Ramona also explained that every time a policy is looked at or changed, there needs to be a disabled person involved.


Kate explained that staff training is very important, in her opinion.
She suggested that the DPC could help employers by sharing ideas for good practice when working with disabled people.
This would be another thing the DPC could do as well as making the 'checklist or 'toolkit'.

## Discussion: Council Decisions and Actions List



Jane asked what the council does to get people in H\&F involved in council decisions.

Peter explained that there are 5 groups for doing this at the moment:

- The Heathrow Commission
- The Air Quality Commission
- The Poverty and Worklessness Commission
- The Business Commission

And, us! The Disabled People's Commission.
The DPC works with Health, Adult Social Care and Social Inclusion too - looking at policies being made.
An idea was suggested that the DPC worked with the Poverty and Worklessness Commission, too.


Peter explained when important decisions are being made, the council cabinet puts the information out 3 months in advance.

Mike explained that the Housing for Disabled People report was coming up on $12^{\text {th }}$ December.

Councillor Lukey explained that this was a chance for a discussion - the decision won't be made on the $12^{\text {th }}$.
The DPC could invite relevant people into the next meeting to talk about this housing report.

Patricia explained that the Sports and Leisure Strategy was being looked at on $16^{\text {th }}$ November.
Fawad said he would try and find out more about this from officers at the council.
Ramona pointed out that she agreed that this was important because of her own problems with a gym not having a disability policy for people who are visually impaired.

Tara explained that she wanted to speak to Councillor Sue Fennimore about the Social Inclusion Forum and how the DPC could work with that Forum.



Dave, Jane and Ramona all explained an interest in the Future Waste and Street Cleansing Service item that will be looked at in January.

Dave, Jane and Ramona all explained how important clear streets and clean streets are for people who are visually impaired, or people who may use a wheelchair or have physical access issues.
