Mystery Shopping launched in spring 2017

What is mystery shopping and what does a mystery shopper do?

Mystery shopping measures the quality of services that residents receive. The mystery shopper's role is to check the standard of services provided by the councils Housing Department.

Who can be a mystery shopper?

You must be a tenant, leaseholder, or household member of a Council property. It would help if you can use a computer and have access to the internet. You will need to write an honest and accurate report of your findings. You should also be reliable, observant and have an eye for detail, along with a good memory.

Tesco Bags of Help - Up to £5,000 Funding Available in Hammersmith & Fulham Tesco Bags of Help will help fund projects focussed on developing outdoor spaces or encouraging the use of outdoor spaces.

Bags of Help is a rolling funding programme so applications can be made at any time. However, if applications are submitted **before Monday 9th January 2017** there is an increased chance of going to the public vote in February 2017.

The Housing Estates Improvement Programme is a scheme funded by the London Borough of Hammersmith and Fulham to transform public spaces on estates so they are greener, safer and benefit the local community. Residents of Hammersmith and Fulham council housing can apply to improve external areas of estates, blocks, or sheltered housing units. The scheme has a budget of £210,000 per year which is allocated to several projects by the resident-led Investment Group. Projects are managed by **Groundwork London**
