Adjoining Sub-area A Parsons Green

Parsons Green LUL Station consists of a twostorey station building with a three-storey
tower on the north side of the railway line,
in Italianate style dating from 1880. Both
platforms have canopies with attractive
timber retaining walls and support posts.
Six cast iron 19th Century bollards, which
are Grade II listed, mark the entrance to
Beaconsfield Walk from Parsons Green Lane.


