#### **HARASSMENT**

The Professional Witness Service has responded to cases of harassment by installing door viewer cameras at the property which record who is approaching a property. We sometimes deploy our covert vehicles near to the areas of concern to capture perpetrators in the act and provide identities where not already known.

#### **DRUG DEALING**

The Professional Witness Service has responded to reports of perpetrators congregating in communal areas, intimidating residents, displaying anti-social behaviour and possible drug use.

To tackle an issue like this, we can install a covert camera inside the building, which is designed to blend in with the surroundings. This enables us to capture the extent of the problem and identify the perpetrators. The evidence we provide for you will assist you to take action. A range of enforcement options are available, for example:
