More than just excellent value

Message from the Leader of Hammersmith & Fulham Council

The government has cut our funding again.

It means by the next financial year they will have made £83million in cuts – which represents a staggering **74 per cent** real terms cut.

Additionally, the government has also scrapped the £1.6million grant that we normally receive for freezing council tax.

Meanwhile, the government has given us new responsibilities that will cost us an extra £650,000 – but won't give us the funding to do it.

They've also asked us to raise council tax by more than seven per cent, which we have refused to do.

Despite this, we are proud to say:

- We're the only council in London to have frozen bills this year and last year, and cut bills the year before.
- Council tax bills in H&F are the third lowest in the country.
- At the same time, we're putting £3.4million more into adult social care.

That's very good news to many people. But we're about more than that, and there's still more to do.











Last year, the majority of H&F residents voted to **remain** in the EU. The vote was followed by an alarming increase in hate crime incidents. We organised a **Unity Day** celebration to bring people together and reaffirm the message that everyone is welcome in H&F. I was delighted that so many people joined us.

Our battle to **save Charing Cross Hospital** continues. Over recent months, thousands of local people have joined us online or at public meetings to campaign to save local health services – particularly the A&E department at Charing Cross.

With demand for care continuing to outstrip existing hospital capacity, and with the local population growing rapidly, the current plans to close local services are more misguided than ever. Standing up for our residents against these closures continues to be our number one priority.

We strive to be the most **compassionate** council by going the extra mile for people who most need our help. That is why we are the only council in the country to **abolish home care charges**.

We have only done this by taking a ruthless approach to cutting waste and radically changing the way the council is run. This booklet will explain more about these changes.

 To help cut pollution, we've opened 150 electric vehicle charging points and a green car club, with one-year free membership for residents.

 We've expanded 20mph safer neighbourhoods across the borough to help reduce congestion and improve safety.

 We're planting grasses to reduce roadside pollution and green corridors for wildlife.

 We're setting up a low emissions zone on the south side of Hammersmith Broadway.





Doing things with local people, not to the

More people than ever are taking an active part in local decisions. Here's how:

 Our business commission has been tasked with developing policies to make H&F the best place to start and grow a business.

 Our air quality commission has driven council policy on electric vehicles, greening town centres, and cycling improvements.

 Our resident-led commission on airport expansion has led on opposing expansion at Heathrow.

 New commissions will be addressing disabled people's services, poverty and worklessness, rough sleepers, biodiversity and the needs of older people.

 Residents have been taking an active part in helping us negotiate a better deal for the West Kensington and Gibbs Green estates.

 We're working with parents and teachers to fight government plans to make massive cuts to local school budgets.





- We've supported new online social network Nextdoor to set up hyper-local virtual neighbourhoods across H&F to share information and solutions to local problems. The vast majority of H&F neighbourhoods now have active groups. For more details visit: www.nextdoor.co.uk
- Local school pupils have elected a Youth Mayor and Youth MPs who have been working with us on a wide range of council policies.

We are working with businesses and local institutions to build the strongest possible economic growth.

Defending Charing Cross Hospital

Since 2014, H&F Council has been **fighting** to save Charing Cross Hospital from proposals to demolish most of the site and replace the A&E service there with a small urgent care centre.

Five local councils, led by Hammersmith & Fulham, commissioned a **public inquiry led by Michael Mansfield QC**.

NHS bosses re-launched their flawed plan in a new report – the 'North West London STP' – and still have the downgrade of Charing Cross Hospital and the sale of much of its site as a key part of their scheme.

H&F Council has totally rejected this and, along with Ealing Council, has refused to sign up to the plan. Both councils are now leading the national debate on opposing STP hospital cuts.

The decision to reject these hospital closure plans was backed by hundreds at a packed town hall meeting in November.

The meeting drew campaigners from across the region who have been fighting plans to close or downgrade services at four out of the nine hospitals in north west London.







Campaigners are united in condemning the tactics being used to force through drastic reductions in local health services secretively and without public consultation.

"Our findings are stark - the reforms, both proposed and implemented thus

far, are deeply flawed. Our
